Engine Control Module Malfunction

Summary

Volkswagen Group of America, Inc. (Audi) is recalling certain 2019-2021 Audi A8 and 2020-2021 Audi S8 vehicles. A missing sealing pin may allow moisture to enter the engine control module connector, possibly causing a control module malfunction.

Remedy

Audi will notify owners, and dealers will inspect the engine control module connector for a missing sealing pin, and install it, if necessary. The connector will also be inspected for corrosion, and replaced as necessary. Repairs will be performed free of charge. The recall is expected to begin April 23, 20121. Lithium-Ion Battery May Short Circuit

Summary

Hyundai Motor America (Hyundai) is recalling certain 2019-2020 Kona Electric and 2020 Ioniq Electric vehicles. The lithium-ion (Li-ion) battery may short-circuit.

Remedy

Hyundai will notify owners, and as an interim action, owners have the option to follow provided instructions to perform a battery update through the vehicle's infotainment system or request a Hyundai dealer to provide the update. Once parts are available, dealers will replace the Battery System Assembly (BSA). Repairs will be performed free of charge. Owners are advised to park their vehicles outside and away from structures until the interim repair is complete. The recall is expected to begin April 30, 2021.
