Inflator May Deploy Improperly

An air bag that deploys improperly may not protect the driver as intended during a crash, increasing the risk of injury.

Summary

Nissan North America, Inc. (Nissan) is recalling certain 2024 Titan, Frontier, Infiniti QX60, Pathfinder, 2023-2024 Sentra, Versa, Kicks, Infiniti QX50, and 2023 Rogue vehicles. Due to a manufacturing issue, the driver's air bag inflator may absorb moisture, and cause the air bag to deploy improperly.

Remedy

Dealers will replace the front driver's air bag assembly, free of charge. Owner notification letters are expected to be mailed April 10, 2024. Owners may contact Nissan customer service at 1-800-867-7669. Nissan's numbers for this recall are PD103, PD104, and PMA34.

Seat Belts May Not Restrain Occupants/FMVSS 208

Improperly restrained occupants have an increased risk of injury during a crash.

Summary

Nissan North America, Inc. (Nissan) is recalling certain 2023 Rogue vehicles. The driver and front passenger seat belt pretensioners may have been incorrectly manufactured, which can cause the seat belts to not properly restrain occupants. As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard number 208, "Occupant Crash Protection," 209, "Seat Belt Assemblies," and 210 "Seat Belt Assembly Anchorages."

Remedy

An unsecured lap belt pretensioner will not properly restrain an occupant during a crash, increasing the risk of injury.

Nissan North America, Inc. (Nissan) is recalling certain 2024 Pathfinder and Infiniti QX60 vehicles. The lap belt pretensioner in the left-side front seat belt assembly may be improperly secured, due to a missing rivet. As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard numbers 208 "Occupant Crash Protection," 209 "Seat Belt Assemblies," and 210 "Seat Belt Assembly Anchorages."

Remedy

Dealers will inspect and replace the left-side front lap seat belt pretensioner assemblies as necessary, free of charge. Owner notification letters are expected to be mailed April 18, 2024. Steering Gear Shaft May Fracture

Fractured steering gear teeth can cause a loss of steering control, increasing the risk of a crash.
