# **Steering Gear Shaft May Fracture**

Fractured steering gear teeth can cause a loss of steering control, increasing the risk of a crash.

#### Summary

PACCAR Incorporated (PACCAR) is recalling certain 2025 Peterbilt 536, 548, 567, 579, and Kenworth T280, T380, T480, T680, T880, and W990 vehicles. The steering gear sector shaft may have been improperly heat-treated, which can cause the gear teeth to crack or fracture.

### Remedy

Dealers will inspect the serial numbers, and replace the steering gears as necessary, free of charge. Owner notification letters are expected to be mailed May 26, 2024. # **Power Steering Pressure Line May Detach and Leak**

A sudden loss of power steering fluid can result in a loss of power steering and power brake assist, increasing the risk of a crash.

### Summary

Jayco, Inc. (Jayco) is recalling certain 2020-2022 Entegra Esteem, Odyssey, and Jayco Greyhawk, Redhawk, and Greyhawk Prestige motorhomes. An inadequate connection between the power steering pressure line and the brake hydroboost unit may result in a sudden loss of power steering fluid.

#### Remedy

Dealers will replace the power steering pressure line and the hydro boost jumper line, free of charge. Owner notification letters are expected to be mailed May 30, 2024. Owners may contact Jayco customer service at 1-800-283-8267.

Front lower control arm failure can cause a sudden loss of steering control, increasing the risk of a crash.

Kia America, Inc. (Kia) is recalling certain 2023 Forte vehicles. The right front lower control arm may have been improperly welded, which can cause it to fail.

Owners are advised not to drive their vehicles until the repair has been performed. Dealers will replace the right front lower control arm, free of charge. ### Remedy

As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard number 108, "Lamps, Reflective Devices, and Associated Equipment."

#### Remedy
