

NHTSA Recalls of Interest July 1, 2024

Front Passenger Air Bag May Not Deploy

A deactivated passenger air bag increases the risk of injury during a crash.

Summary

Volkswagen Group of America, Inc. (Volkswagen) is recalling certain 2021-2024 Atlas and 2020-2024 Atlas Cross Sport vehicles. The passenger occupant detection system (PODS) may experience a fault in the wiring and deactivate the front passenger air bag when the seat is occupied.

Remedy

Dealers will replace the PODS sensor mat and wiring harness, free of charge. Owner notification letters are expected to be mailed August 16, 2024. Owners may contact Volkswagen's customer service at 1-800-893-5298. Volkswagen's number for this recall is 69PZ.

Curtain Air Bag May Deploy Improperly/FMVSS 226

An improper deployment of the side curtain air bag can reduce occupant protection during a crash, increasing the risk of injury.

Summary

Toyota Motor Engineering & Manufacturing (Toyota) is recalling certain 2024 Toyota Grand Highlander, Grand Highlander Hybrid, Lexus TX350, TX500 Hybrid, and TX550 Hybrid+ vehicles. The driver's side curtain air bag may not unroll as intended and could partially deploy outside of an open window. As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard number 226, "Ejection Mitigation."

Remedy

The remedy is under development. Interim letters notifying owners of the safety risk are expected to be mailed between August 5, 2024 and August 19, 2024. A second notice will be sent once the remedy is available. Owners may contact Toyota customer service at 1-800-331-4331. Air bags that do not deploy as intended can increase the risk of injury in a crash.

Remedy

A rearview camera with a delayed or deactivated image reduces the driver's view of what is behind the vehicle, increasing the risk of injury or crash.

TPMS Light May Not Illuminate/FMVSS 138

A TPMS warning light that fails to illuminate can result in the vehicle being driven with improperly inflated tires, increasing the risk of a crash.
